CONFLUENCE PUMPKINFEST OCTOBER 4th, 5th, & 6th - 2019

RULES & REGULATIONS

The Pumpkinfest Festival Committee will sponsor Pumpkinfest 2019 on October 4th, 5th, 6th. Pumpkinfest will be held in the center of Confluence PA on Friday afternoon, Saturday and Sunday. It will feature various arts, crafts and food. All vendors who wish to participate in Pumpkinfest MUST fill out a registration form, including a complete list of all items you wish to sell and return it along with their fees by September 01, 2019. All items submitted for sale must be approved by the committee so as not to have too many of one item, however we are not responsible for duplications. You will be notified prior to acceptance of your payment of any items not approved for sale on your list or if your application is rejected. **No one will be permitted to sell any items not listed and approved on your registration form.**

EVENT POLICIES - COMMERCIAL VENDORS (LATE FEE WILL BE CHARGED AFTER SEPTEMBER 01-2019)

Those selling food or wares (other than homemade art or craft items, or local vendors & local nonprofit organizations). (Local: those with a 15424, 15411, 15540 and 15485 zip codes and living at that address) Each \$350.00 entitles vendor to 1 - 10 ft. by 30 ft. space, (for the 3 day festival) with electric. Additional space is \$110.00 per 10 ft. by 10 ft. space. You must specify what type (110V or 220V) and amperage electric service you need on your application. No additional electric service will be available at the Festival! **No food vendors are permitted to sell the following: hamburgers, hot dogs, shoestring fries, nachos, or pumpkin pies. No exceptions!!!** No Vendor spaces available after September 22-2019, Late penalties will be added after September 01-2019
All checks must clear by September 22-2019

EVENT POLICIES - OTHER VENDORS (LATE FEE WILL BE CHARGED AFTER SEPTEMBER 01-2019)

Local, Nonprofit & Craft Vendors: Each \$75.00 entitles registrant to a 10 X 10 foot space for the 3 day festival. Pumpkinfest 2018 is (Friday afternoon, Saturday and Sunday, October 5th, 6th, & 7th). Additional \$10.00 fee for electrical service. (Includes one 20 amp, 115 volt receptacle with 2 plug-ins.) If you require additional electricity, specify your requirements on your application and add \$10.00 for each additional circuit required. Only electric hookups stated on your form will be available during the Festival. Late penalties will be added after September 01-2019. **All checks must clear by September 22-2019**

EVENT POLICIES - ALL VENDORS !

GRAY WATER MAY BE DUMPED ONLY IN PROPER LOCATIONS

Spaces will be assigned randomly to all registrants. Provide Email on application for space conformation. **Booth setup can begin at 6:00 PM Thursday Oct. 3rd**. To be assured of a space, **vendors fees must be paid by SEPTEMBER 01-, 2019**. We will try to place last year's vendors in the same location but **will not guarantee** the spot. All vendors' fees are NONREFUNDABLE, if accepted. **Vendors are expected to be open till closing unless they run out of merchandise (NO CHECKS WILL BE ACCEPTED AFTER SEPTEMBER 20th, 2019 CASH OR MONEY ORDER ONLY)**

DO NOT USE LAMP CORD FOR EXTENSION CORD

USE HEAVY DUTY POWER STRIP

Absolutely no vehicles will be permitted on festival grounds after 2:00 PM on Friday or after 9:00 A.M. on Saturday through Sunday at 9:00 P.M. You must supply your booth from outside the grounds during the festival. No tearing down before closing Sunday unless special permission is given by committee. **(ELECTRICITY WILL NOT BE AVAILABLE BEFORE FRIDAY AFTERNOON.)** Vendor parking may be available at our Barlow St. building. We may have some room for travel trailers, first come first served.

Tents or other devices that might damage park grounds are not permitted. Registrants should be prepared for inclement weather. **Registrants must provide their own tables, booths, and garbage cans with bags for their space.** Garbage will be picked up periodically during the day. There will be garbage cans throughout the grounds for visitors only. All cardboard boxes must be flattened and placed in the dumpsters. **Booths are scheduled to be open 2:00 PM (weather permitting) to 9:00 PM on Friday, 9:00 AM to 9:00 PM on Saturday and 9:00 AM to 9:00 PM on Sunday.** Vendors are not permitted to use the logo or name of Pumpkinfest or the logo and/or name "Where mountains touch rivers" on any items they are selling without written permission of the Pumpkinfest Festival Committee. Vendors are not permitted to sell **SMOKE, BOMBS, SPRAY PAINT OR FOAM, ANY KIND OF GUNS, EVEN TOYS OR ANYTHING WITH PROJECTILES, SATANIC ITEMS, OR DRUG RELATED PARAPHERNALIA.**

You must specify on the contract the type and size of booth, (trailer, tent, canopy, etc.), and which side you wish to sell from. Absolutely no roller blades, skates, skateboards or bikes will be permitted to be used on the festival grounds during the festival. **NO PETS, PLEASE.** Overnight security will be provided for Friday, and Saturday nights from 10:00 PM to 6:00 AM. Pumpkinfest sponsors are not responsible for fire or theft of any vendor items while on festival grounds.

By signing the registration form, you agree to abide by the above said policy of the Pumpkinfest Committee. Failure to do so will result in the immediate expulsion from said grounds and legal action may be taken against you.

Pumpkinfest is co-sponsored and operated by the Confluence Vol. Fire Department, Confluence Ambulance Service, and Confluence Borough.
